ORGANISER

This activity is organised by Nordisk Ungdomsorganisation (NordUng), with English translation Nordic Youth Organisation (NordYouth).

EVENT DESCRIPTION

This is a workshop to further understand what active participation means. We use non-formal education methods to:

- 1) discuss democracy, active citizenship, inclusion in our societies, peaceful community building
- 2) get a common understanding of active participation,
- 3) learn to analyse the needs of young people when it comes to active participation and relate it to your own communities, NGOs and societal structures,
- 4) produce text/video/audio material as NGO tools supporting young people to take first steps towards becoming more active participants in society.

PARTICIPANT PLACES

Participants should be young people interested in the content who are at last 20 years old.

NB! Priority is given to applicants under 30 years old.

NordYouth handles the applications until the places are filled.

ACCOMMODATION, MEALS, PROGRAMME AND LOCAL TRANSPORT

Active Participation Workshop 2024 is held in Göteborg, Sweden. The project provides accommodation, meals, programme and local transport in Göteborg.

TRAVEL ARRANGEMENTS

Please arrive to Göteborg on the 13th of March. Departures are from the evening of the 17th of March (also in the morning of 18th if not possible to travel on the evening of 17th).

TRAVEL REIMBURSEMENT

NordYouth reimburses travel expenses up to a certain amount of actual costs. NordYouth reimburses 80% of the travel costs for this activity.

Due to the strict regulations by our funders, please follow these instructions to receive reimbursement:

- Participate fully and actively in the programme
- Most economical way of travel must be used (economy class flights, 2nd class train etc.)
- Documentary evidence must be provided for all travel costs within 2 months after the travel: ticket showing travel route, price paid and the date of payment. If the ticket lacks information about amount or date of payment, add bank or credit card statement. Boarding pass is required for travel by plane and ferry.
- Any payment over 1000€ need to be supported by a bank/ credit card statement.

INSURANCE

The organiser do not offer travel insurance or cover costs for it. Participants are advised to have travel insurance that covers health care costs, and preferably also luggage. It is recommended that the insurance or the travel tickets include cancellation protection in case of illness. Please also bring a European Health Card (E111) as travel insurance may not cover costs that should be covered by E111. It can be ordered for free from your national health care web page/office.
